1. This product is warranted for 12 (twelve) months from the date of purchase, subject to the terms and conditions contained herein.
2. The product will be repaired or replaced by Dot 1 Pty Ltd, if, at their sole discretion, it is found to be faulty within the warranty period.
3. This warranty only applies to products sold and distributed within Australia by Dot 1 Pty Ltd and its authorised dealers and / or retail outlets.
4. This warranty only applies to products that are proven to be purchased in Australia with an official receipt of purchase from Dot 1 Pty Ltd and it's authorised dealers and / or retail outlets.
5. This warranty only applies if the product has been used in accordance with the manufacturers instructions under normal use and with reasonable care (in the opinion of Dot 1 Pty Ltd) subject to all terms and conditions set out in this document.
6. This limited warranty does not cover any of the following:
 - a. Defects or damages resulting from misuse of the product;
 - b. Defects or damages from abnormal use, abnormal conditions, improper storage, exposure to moisture, oils or solvents, extreme environmental changes such as temperature and humidity, dampness or corrosive environments, unauthorised modifications, unathorised repair, neglect, rough handling, abuse, accident, alteration, improper installation, food or liquid spillage or acts of God.
 - c. The cost or delivery or transportation of the product to the dealer;
 - d. Normal wear and tear;
 - e. If the product has been opened, modified or repaired by anyone other than Dot 1 Pty Ltd;
 - f. This warranty is not transferable. This warranty is only valid for the original purchaser and does not apply to any subsequent purchaser / end user.
